Internal control deficiencies in programs and processes could lead to misstatements in Department of Homeland Security (DHS) financial statements. Also, these deficiencies could impair effective monitoring and execution of Federal programs.

What We Determined

KPMG LLP reviewed U.S. Immigration and Customs Enforcement's (ICE) internal control over financial reporting. The management letter contains five comments and five recommendations related to internal control and other operational matters for management's consideration. KPMG LLP noted deficiencies and the need for improvement in certain ICE programs and processes. These deficiencies did not meet the criteria to be reported in the Independent Auditors' Report on DHS' FY 2013 Financial Statements and Internal Control over Financial Reporting, dated December 11, 2013, included in the DHS FY 2013 Agency Financial Report. These comments are intended to improve internal control or result in other operating efficiencies. We do not require management's response to the recommendations.
