Why We Did This Audit

On May 5, 2017, Congress enacted Public Law 115-31, *Consolidated Appropriations Act, 2017*. According to Division F, Section 103(a), the Secretary of the Department of Homeland Security shall submit a report not later than October 15, 2017, to the DHS Office of Inspector General listing all grants and contracts awarded by other than full and open competition (OTFOC) during fiscal years 2016 and 2017.

We contracted with Williams, Adley & Company-DC, LLC to review the OTFOC report and assess DHS compliance with applicable laws, regulations, and departmental procedures.

What We Recommend

What We Found

Williams Adley concluded that DHS complied with applicable statutes, regulations, and policies governing grants and contracts awarded by OTFOC in FY 2017. During that year, DHS awarded 62 noncompetitive grants worth about \$140 million and 121 noncompetitive contracts worth about \$118 million through OTFOC. The independent auditors determined that DHS' Report on OTFOC for FY 2017 as well as the information related to these grants and contracts in the Federal Procurement Data System – Next Generation and USASpending.gov were accurate. The auditors also found that DHS followed written policies and procedures and the requirements of the *Federal Funding Accountability and Transparency Act of 2006* when awarding grants and contracts noncompetitively.

DHS' Response

The Department did not provide formal management comments for inclusion in the final report.





Executive Summary

We completed a performance audit of the DHS Secretary's report on grants and contracts awarded by any means other than full and open competition (OTFOC) during fiscal year 2017. The audit included a review of approximately \$140 million in grants and \$118 million in contracts awarded by any means OTFOC.

Overall, we determined that DHS' Report on Grants and Contracts Awarded by Any Means OTFOC during FY 2017 was accurate and that information related to these grants and contracts recorded in the Federal Procurement Data System – Next Generation (FPDS-NG) and in USASpending.gov is accurate. DHS also followed written policies and procedures when awarding grants and contracts noncompetitively. This report contains no recommendations.

Background

According to the *Competition in Contracting Act of 1984*, with limited exceptions, contracting officers are required to promote and provide for full and open competition in soliciting offers and awarding Federal Government contracts. The Federal Acquisition Regulation (FAR) codifies uniform policies for acquiring supplies and services by executive agencies and requires Federal agencies to collect and report data to the FPDS-NG.

The Government uses the data in FPDS-NG to measure and assess the impact of Federal procurement on the Nation's economy. The system includes information on funds obligated and the extent of competition. FAR 4.604 requires Federal agencies to certify annually that the grant and contract data entered in FPDS-NG is accurate and complete.

On May 5, 2017, Congress enacted Public Law 115–31, *Consolidated Appropriations Act, 2017*. Division F of this act is the *Department of Homeland Security Appropriations Act, 2017*, section 103(a), which requires the Secretary of Homeland Security to submit a report to the DHS Office of Inspector General (OIG) listing all grants and contracts awarded by OTFOC during fiscal years 2016 and 2017. Section 103(b) requires the OIG to review this report to assess departmental compliance with applicable laws and regulations and to report the results of that review to the Committees on Appropriations of the United States Senate and House of Representatives.

According to FAR 6.301 and 6.302, executive agencies (with exceptions) may authorize, under certain conditions, contracting without providing for full and open competition. Contracts awarded through OTFOC are permitted when:

- Only one responsible source and no other supplies or services will satisfy agency requirements;

- The need for the supplies or services is of such an unusual and compelling urgency that the Government would be seriously injured unless the agency is permitted to limit the number of sources from which it solicits bids or proposals;
- It is necessary to award the contract to a particular source or sources in order to maintain a facility, producer, manufacturer, or other supplier available for furnishing supplies or services in case of a national emergency or to achieve industrial mobilization;
- It is necessary to establish or maintain an essential engineering, research, or development capability to be provided by an educational or other nonprofit institution or a federally funded research and development center;
- Full and open competition is precluded by the terms of an international agreement or a treaty between the United States and a foreign government or international organization;
- A statute expressly authorizes or requires that the acquisition be made through another agency or from a specified source; or
- The disclosure of the agency's needs would compromise the national security.

Engagement Objective

We conducted a performance audit to assess DHS' compliance with applicable statutes, regulations, and policies governing grants and contracts awarded by OTFOC during FY 2017. Specifically, our objectives were to:

- Determine the accuracy of the Director's annual report detailing all grants and contracts awarded by OTFOC;
- Ensure that all grants and contracts awarded by OTFOC were properly recorded into the FPDS-NG;
- Ensure that all grants and contracts awarded by OTFOC were properly recorded into the USAspending.gov data system;
- Confirm the existence and use of processes to compare and report the accuracy of spending information against the official record of agency accounts at quarterly intervals;
- Ensure all agency contracts awarded by any means OTFOC were in full compliance with the following FAR Sections:
 - FAR 6.301 – Policy
 - FAR 6.302 - Circumstances Permitting OTFOC
 - FAR 6.303 – Justifications
 - FAR 6.304 - Approval of the Justification; and
- Ensure all U.S. Coast Guard contracts awarded by OTFOC complied with 10 U.S.C. 2304(c).

Scope

We audited the DHS Secretary’s report on grants and contracts awarded by any means OTFOC (Department’s Report) for the period October 1, 2016 to September 30, 2017. Although FY 2016 information was presented in the Department’s Report, the scope of the audit did not include the FY 2016 information.

Criteria

The following criteria are applicable to this audit:

- Government Auditing Standards, also known as Generally Accepted Government Auditing Standards (GAGAS), issued by the Comptroller General of the United States, GAO-12-331G, December 2011;
- Generally Accepted Auditing Standards (GAAS), as established by the American Institute of Certified Public Accountants (AICPA) and promulgated in its Statements on Auditing Standards (SAS) and Statements on Standards for Attestation Engagements (SSAE);
- Federal Acquisition Regulation (FAR) 6.301 – Policy;
- FAR 6.302 - Circumstances Permitting Other Than Full and Open Competition;
- FAR 6.303 - Justifications;
- FAR 6.304 - Approval of the Justification; and
- Title 10 U.S.C. 2304(c) - For U.S. Coast Guard Contracts.

Methodology

To achieve our audit objectives, we performed the following:

- Interviewed DHS, U.S. Coast Guard, and FEMA management officials to gain an understanding of their processes and controls in place regarding awarding grants and contracts by OTFOC. We obtained and inspected policies and procedures used by DHS and its components to award non-competitive grants and contracts.
- Assessed the adequacy of DHS’ process for certifying FPDS data quality in accordance with the Office of Management and Budget Memorandum – *Improving Federal Procurement Data Quality – Guidance for Annual Verification and Validation*, reviewed DHS’ Annual Certification of FPDS Data Quality for FY 2017, and performed inquiries of any discrepancies noted.
- Compared key data elements between the Department’s list and list of contracts in FPDS to determine completeness and accuracy.
- Compared the Department’s list to USAspending.gov raw agency

submission files C, D1, and D2 and assessed DHS’ process for comparing and reporting on the accuracy of spending information.

- Selected statistically-valid, random samples of grants and contracts awarded by OTFOC. We selected separate samples for grants and contracts using IDEA statistical sampling software and a confidence level of 90%, tolerable deviation rate of 10%, and expected deviation rate of 0%. We reviewed supporting documentation provided by DHS, as described in the Results of Audit section under Noncompetitive Grants Reported in FY 2017 and Noncompetitive Contracts Reported in FY 2017. We reviewed contract and procurement files to determine whether grants and contracts sampled complied with FAR and 10 U.S.C. 2304(c) guidance on OTFOC procurements, as applicable.

We assessed the reliability of OTFOC data by (1) performing testing of required data elements, (2) reviewing existing information about the data and the system that produced it, and (3) interviewing agency officials knowledgeable about the data. In addition, we traced statistically-valid, random samples of data to source documents. We determined that the data was sufficiently reliable for the purposes of this report.

We conducted this performance audit in accordance with generally accepted government auditing standards. Those standards require that we plan and perform the audit to obtain sufficient, appropriate evidence to provide a reasonable basis for our findings and conclusions based on our audit objectives. We believe that the evidence obtained provides a reasonable basis for our findings and conclusions based on our audit objectives.

Results of Audit

DHS noncompetitively awarded 62 grants valued at \$140 million during FY 2017, which is similar to FY 2015 and 2016. Additionally, DHS noncompetitively awarded 121 contracts totaling \$118 million. The number of noncompetitive contract awards has steadily decreased since FY 2015.

In October 2017, DHS submitted the Listing of All Grants and Contracts Awarded by Any Means Other Than Full and Open Competition to DHS OIG. As required by P.L. 115-31, Division F, Section 103(b), we reviewed the DHS' FY 2017 noncompetitive grants and contracts listing to assess departmental compliance with applicable laws, regulations, and departmental procedures.

DHS Certifications

We reviewed DHS' annual certification of FPDS data quality submitted for FY 2017 and compared the Department's Report to the list of FPDS noncompetitive contracts awarded (see Appendix B for details). DHS certified that 99.9% of reportable contract actions awarded during FY 2017 were entered into FPDS-NG. Additionally, DHS certified that 96.8% of actions reported were within appropriate timeframes and in accordance to applicable guidelines.

We also reviewed DHS' *Federal Funding Accountability and Transparency Act of 2006* (FFATA) and *Digital Accountability and Transparency Act of 2014* (DATA) certifications during FY 2017.¹ On the FFATA internal certification for first quarter FY 2017, the DHS components certified that the submissions were accurate and complete. On DHS' FY 2017 DATA certifications for quarters two through four, the Senior Accountable Official certified that internal controls support the reliability and validity of DHS' account-level and award-level data reported for display on USASpending.gov.

Noncompetitive Grants Reported in FY 2017

From a population of 62 grants awarded by OTFOC, valued at \$140,166,300, we selected a statistically valid, random sample of 17 grants valued at \$30,186,037. We tested the sample of noncompetitive grants by obtaining supporting documentation such as the grant agreement, Notice of Funding Opportunity, and Sole Source Justification, as applicable, to determine whether procedures were followed and whether DHS had proper justification for the noncompetitive awards. We compared the key data elements (such as grant recipient, award amount, award ID #, FY awarded, and awarding component) from the Department's Report to the data recorded in USASpending.gov to ensure that data elements were properly reported. No exceptions were noted during our testing.

¹ FFATA was applicable for 1st quarter FY 2017. The DATA Act was applicable beginning 2nd quarter FY 2017.

Noncompetitive Contracts Reported in FY 2017

During FY 2017, DHS awarded 121 contracts by OTFOC, with a total obligated amount of \$117,540,372. From these contracts, we selected a statistically-valid, random sample of 19 contracts with a total obligated amount of \$12,923,440. We reviewed supporting documentation such as the contract, justification and approval form, market research, and evidence of a review process to determine if proper procedures were followed and DHS had proper justification for awarding the contracts noncompetitively. We also compared key data elements (such as contracting agency, Procurement Instrument Identifier, description of contract, extent competed, amount obligated) from the Department’s Report to the data recorded in FPDS-NG to ensure that samples were properly reported in FPDS-NG. No exceptions were noted during our testing.

The Consolidated Appropriations Act, 2017 (P.L. 115-31) Division F, Title I, Section 103 (a), requires that "The Secretary of Homeland Security shall submit a report not later than October 15, 2017, to the Department of Homeland Security (DHS) Office of the Inspector General (OIG) listing all grants and contracts awarded by any means other than full and open competition during Fiscal Years (FYs) 2016 and 2017."

Excluded from this summary are the disaster grants awarded under the authority of the Robert T. Stafford Disaster Relief and Emergency Assistance Act.
